Terms and Conditions

LEGAL NOTICE AND ACCEPTANCE

2. SUBJECT MATTER

At the Portal, BODEGA LUIGI BOSCA / FAMILIA ARIZU grants Users access to and use of a variety of services and content (hereinafter, the "Services") made available by BODEGA LUIGI BOSCA / FAMILIA ARIZU or by third parties.

3. TERMS AND CONDITIONS OF PORTAL ACCESS AND USE

3.1. Access to and use of the Portal are free of charge
